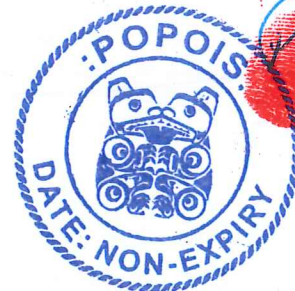

### LEGAL PUBLIC NOTICE TO:

### ALL CORPORATIONS, THE CROWN & PEOPLES OF KANATAN

CORPORATIONS OF THE PROVINCES, CORPORATION OF CANADA, PERSONS et al, STATUS INDIANS et al, IMMIGRANTS, Government agents et al and all agents of the CROWN et al, B.A.R., Lawyers et al - Made this Day: January 11, 2022

**De Jure Government** Peoples of the Salmon et al, as the Original Peoples of Kanatan, is the First Law of the Land of Kanata. All Corporations acting upon the lands do so under the "Corpus juris secundum" a body of law (Kamloops Court of BC, November 17<sup>th</sup> 2020), which came after the settlement on the original peoples' lands. Peoples of the Salmon operate under the administration of a Tribunal (year 1704) of "said Indians" (1763 Royal Proclamation by King George), members recognized by Queen Anne's Order in the year 1704. BRITISH COLUMBIA/CANADA are corporations under Admiralty Law, now in bankruptcy. Acts, Regulations and Statutes of these Corporations are NOT Laws. The lands were never purchased by Her Majesty of Great Britain: Thus the Crown Corporations distribution of an 'Experimental Bioweapon', according to the Nuremberg Code and Helsinki Accords, is a Criminal Act of Genocide and therefore **Treason**. Peoples of the Salmon revoke all Business of these De facto Corporation Governments.

Our new Allies "Wolverines" adopted in our Custom and Tradition are Sovran and not subject to the Certificate of Live Birth, registration in the Vital Statistics Act. The Birth Certificate, and Injections are applicable only as jurisdiction over the FREEMAN and Her Majesties subjects. The Sovran being is non-consenting to the governing of Injections (aka vaccines) by the Corporation over our Peoples, "By Force - Occupied Lands." All Treason against HER Majesty in Council of Great Britain [corporation] / With Prejudice.

The Tribunal, High Councils and Matriarchs have no Treaties with these Corporations. Any International Treaty signed by these Corporations is unlawful, as Criminality and Treason is their Edict.

Any future [in]teraction with our Sovereign Member(s) may only be enacted with re-presentation of legal/ lawful Title Documents of PERSON or DEED and TITLE to the Original Peoples Lands across the Alliance of Kanatan. Our member(s) is Free to Travel [un]encumbered, across Turtle Island as Original People have for millennia, under Postal Registry:

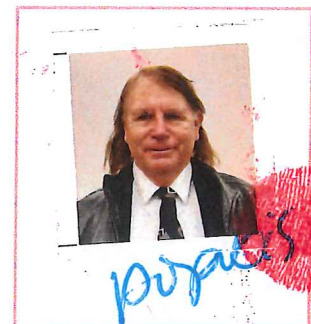

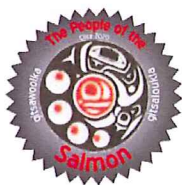
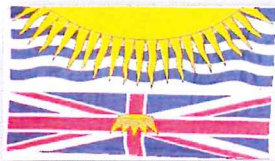
