*[giving Permission to the Provost Marshal to enforce the rights of the sovereign Peoples of Kanatan]*

By the Headsman and TRIBUNAL members of the Peoples of the Salmon and Alliances

To all whom it may concern: Satisfactory evidence having been exhibited to me:

Brigadier-General Simon Trudeau

Provost Marshall and Foreign Consul of Kanatan at TOMMY JASS for the Peoples of the Salmon

I do hereby recognize him as such and declare him free to exercise and enjoy such functions, powers and privileges as are issued by this Exequatur:

1. The functions, powers, and privileges are granted from authority of the sovereign and through the new Government of Kanatan with the promise of payment to the new Kanatan Military Forces for the exchange of admiralty and maritime military performance;
2. Protection of the current citizens of CANADA/Canada and all peoples of Kanatan, current and future immigrants into the Kanatan territory;
3. Merging of the Canadian forces into the Kanatan Military Forces;
4. Re: West Jet's refusal to accept Exemption Pass and Sherpa protocols

Dear Madam/Sir:

The morning of the February 25th, I had a flight to leave for Ottawa West Jet. I understand the Sherpa documents of the Ontario government allow for travel to Ontario without vaccination and CoVID PCR tests. According to Constitutional laws you must follow Sections 7 and 35(1), which you cannot override without consent. CoVID protocols are Crimes against humanity, genocide and distribution of a bioweapon. The Nuremberg Code and Helsinki Accords are accepted on the unceded lands of "Kanatán" (Sacred Lands) [not CANADA Corporation]. In addition, West Jet's refusal to accept my Exemption Pass and Sherpa protocols violate my Rights to travel under the Jay Treaty. Your Agency now has Notice and knowledge that my fee schedule of \$1000 per minute is in effect until my Travel is allowed. West Jet was informed of my Fee schedule at 5:10 am February 26<sup>th</sup> to the Supervisor.

"Travellers will need to show airlines and railway proof of vaccination. For a short transition period until November 29, 2021, travellers have the option to show proof of a valid COVID-19 molecular test in order to board. Airlines and railways will be responsible for confirming the vaccination status of travellers. In the aviation mode, the Canadian Air Transport Security Authority (CATSA) will also support operators by confirming vaccination status."

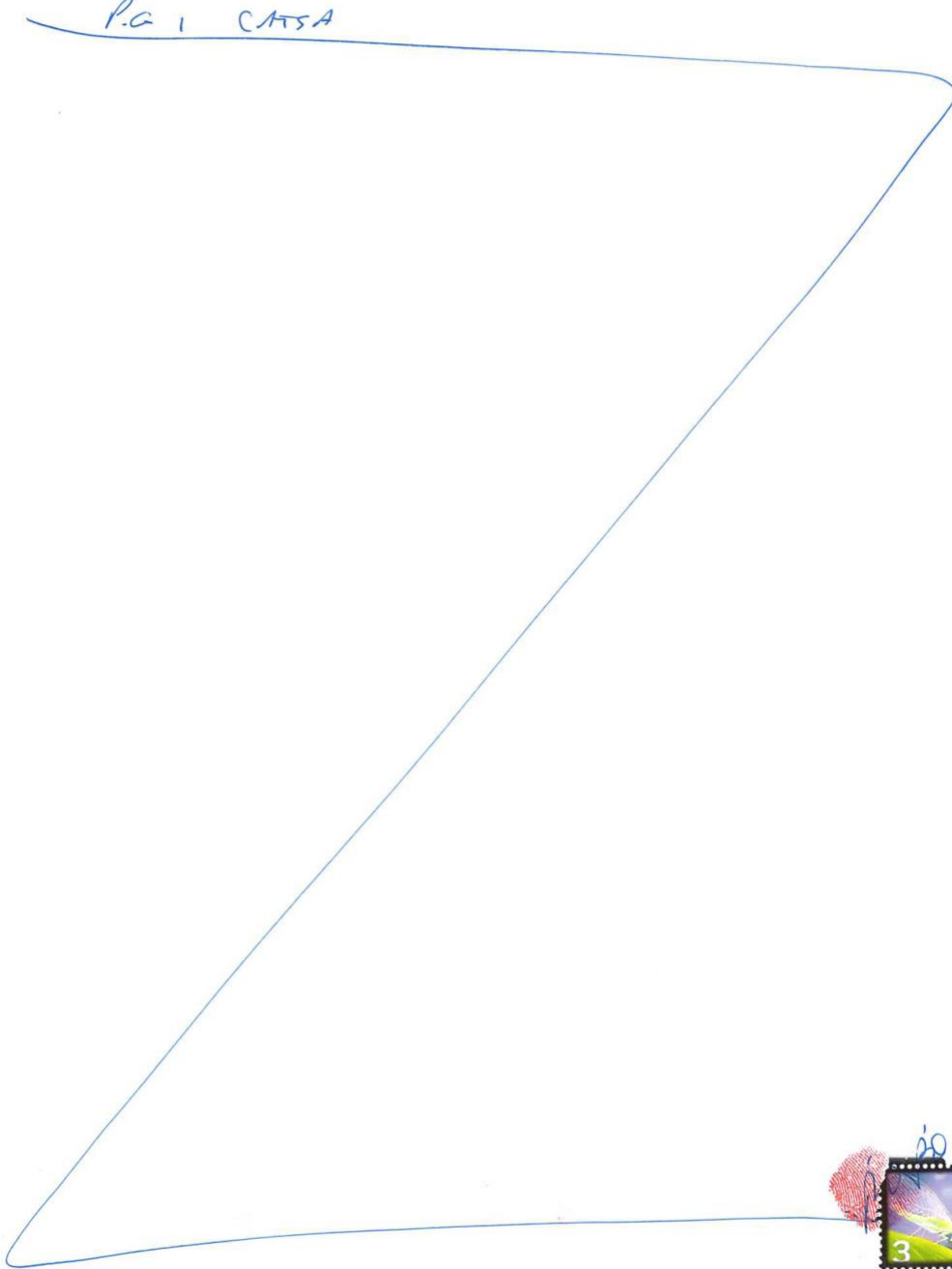
I wish to draw your attention to Federal Court File T-168-22 between the Honourable A. Brian Peckford's clients against the Minister of Transport, Hon. Omar Alghabra, January 31<sup>st</sup>, 2022, (attached) wherein the 'Decisions' of the Vaccine Provisions clearly violate our human Charter Rights in addition to our Sovereign Rights and Freedoms. No man is above the Law of God. I encourage you to review the attached "Notice of Application" to the end starting at page 13, "(d) Interim Order 52 is ultra vires the enabling statute." (file attached)

The "Vaccine" according to the Pfizer product file, and the attached recently released **Court Ordered Pfizer Adverse Events Report** (which they planned to hold back until 2085) is shown to be extremely dangerous and even genocidal, with 9 pages of adverse events, including massive death. In the initial trials, out of 46,000 people who received the 'experimental bioweapon,' 42,000 (80%) suffered severe adverse effects and 1,200 (5.5%) died. Each set of trials contains 20% placebos for the "control group"... Only 20% of those who were dosed did not have adverse effects. In other words, 100% of the active doses caused adverse events and death. The FDA rules are that just one death within 30 days of taking an experimental trial drug closes down the trial. This never happened. We need to ask WHY.

1. In respect of an act or omission in obedience to the laws, for the time being, made and enforced by persons in de facto possession of the sovereign power in and over the place where the act or omission occurs. We the Peoples of the Salmon do require the Treasury of Solomon holder to provide us with a Trust fund.
1. On the Title Lands of the Peoples of the Salmon, and across the Alliances of Kanata our central banking system will provide the People with a wallet and a resource backed digital currency of our own design and making.
2. § 1-202. Notice; Knowledge.
  - a) Subject to subsection (f), a person has "notice" of a fact if the person: (1) has actual knowledge of it; (2) has received a notice or notification of it; or (3) from all the facts and circumstances known to the person at the time in question, has reason to know that it exists.
  - b) "Knowledge" means actual knowledge. "Knows" has a corresponding meaning.
  - c) "Discover", "learn", or words of similar import refer to knowledge rather than to reason to know.
  - d) A person "notifies" or "gives" a notice or notification to another person by taking such steps as may be reasonably required to inform the other person in ordinary course, whether or not the other person actually comes to know of it.
