Re: Open Notice to All Healthcare Practitioners of British Columbia, Canada

Take Notice: This Our open Notice is addressed to all women and men skilled in the arts of medicine admitted upon any of the several registries as medical or nurse practitioners, or of the several other disciplines serving the public, in the preservation or improvement of the health of individuals, or the treatment or care of individuals who are injured, sick, disabled or infirm (herein “Practitioner”).

We are entrusted with the first law of the land, the original Sovereign peoples (a.k.a. First Nations) of the land known to the public as the territory of British Columbia *at large*, having and holding Our sovereign powers and prerogatives *in toto*, unattached to the Corporation of Canada¹, free to associate, allied in bond of peace as Sovereigns with Her Majesty the Queen of [the Dominion of] Canada in whom by the laws of Canada the powers and prerogatives of Her realm are vested.²

From a health perspective, the recent acts and omissions of the College of Physicians and Surgeons have resulted in unprecedented wrongs and injury calling into disrepute the profession on multiple levels, diminishing the confidence in the profession in general. Pursuantly, on the relation of a private individual, Sovereign, or Practitioner, we are intent upon calling by prerogative writ for the forfeiture or dissolution of the Charter of the College of Physicians and Surgeons (incorporated 1886) (the “Corporation”) or have ousted its board members on the grounds that the Corporation is committing such egregious and ultra-virus acts under such circumstance as to offend the conscience amounting to an utter departure from the business or purposes for which it was organized; all occurring upon Our lands to Our great offence working a wrong to Our and all peoples.

To work any of the above remedies on the ground of misuser or abuse of corporate powers, there should not only be a wrong, but one arising from wilful abuse or improper neglect. The corporate default must be something more than accidental negligence or mere mistaken excess of power, or mistake in the mode of exercising an acknowledged power. There must be an abuse of trust, of such a nature as would render a trustee liable to forfeit his station on a complaint.

The side effects involving the vaccines and their assumed, presumed, and implied side effects, has led us to believe that these still births are what prompted these doctors to act. One still birth was recorded in the previous

six months, and has been recorded multiplied by thirteen times currently.

Accordingly, we are intent upon assembling in Our name and under Our jurisdiction a Board of Trustees constituted of allied Practitioners, to assemble other Practitioners to inform upon affidavit such egregious acts in testimony whereof as against said Corporation.

Should our writs be successful against the Corporation, it is the duty of the court to appoint trustees to handle the assets of the Corporation, collect the same and discharge the obligations of the Corporation giving rise for the need of establishing the said Board of Trustees.

In furtherance of our sovereign objects, moving forward for the betterment of Our and all peoples through access to wellness and care, we are intent upon pronouncing by proclamation wherefore Practitioners in good standing allied with our purposes will be issued Our sovereign grants of franchise to continue, *in personam*, perfecting their art for said righteous purpose.

A new day has dawned upon us all, we have arisen and we call upon Practitioners to assemble and associate a Board of Trustees anew to create functional systems of wellness built on integrity and transparency, certifying and recording in the rolls, in Our Name, all allied Healers. Our desire is to build a system for all doctors, surgeons, nurses, healthcare workers and first responders to continue perfecting their art on Our land, within Our jurisdiction, by Our authority, and for greater certainty, without the Corporation.
