Since 1860 CANADA has been registered as a Corporation [SEC sic 8880] until March 30 2013 when it changed to a foreign Government in November 2013.

To whom it may Concern,

As CANADA is a Foreign Government, de facto in Nature, the Peoples of the Salmon have suspended all the money available to its operations. It has been in bankruptcy since April 15, 2017 and ending 5 years later, April 28,2022.

We ask you to detain these Actors for Crimes against Humanity, Genocides and Fraudulent distribution of 'experimental bioweapons' in the form of an emergency vaccination.

We have accepted international Law on our Lands to invoke the Nuremberg Code and Helsinki Accords for these crimes against the Original Peoples of Kanatan (Sacred Land). The sovereign People have adopted all the races, as Wolverines, to help share responsibility, to care for all living flesh blood bone and the natural world kingdoms on our land, to walk with us in love, peace and harmony on the Creators path of Benevolence.

Since the beginning of the mandated "experimental bioweapon" without the informed consent of the People, the number of reported cases of corona virus in addition to multiple other severe adverse events and deaths rose from 150,000 in 2020 to 3.8 million by May 1, 2022 - 10% of

We seek assistance from our own military and recovery of the currency from the Central Bank of Canada to assist in paying this security Force. These actors in positions of governance have no authority or jurisdiction to continue using our currency to murder our Peoples.
