#### APPOINTMENT & EXEQUATUR: 20220322

*[bestowing Permission on the Provost Marshal to enforce the Rights of the Sovereign Peoples of Kanatan]*

By the Headsman and TRIBUNAL members of the Peoples of the Salmon and Alliances

To all whom it may concern: Satisfactory evidence having been exhibited to me:

Brigadier-General Simon Trudeau

Provost Marshall and Foreign Consul of Kanatan at TOMMY JASS for the Peoples of the Salmon

I, Popois, do hereby recognize him as such and declare him free to exercise and enjoy such functions, powers and privileges as are issued by this Exequatur:

1. We have neutralized the office of the Prime Minister.
2. We require you to stop the Bank of Canada, as being a fiduciary to the CANADA Corporation.
3. To enforce the Cease and Desist Order of July 21, 2021 and arrest the Actors committing Crimes against Humanity, the Peoples of the Salmon and Alliance members of Kanatan.
4. Arrest the dishonourable Justin Trudeau, Chrystia Freeland and Mélanie Joly (in the Ukraine) for treason and crimes against humanity.
5. Accept our offer of a digital wallet to pay all of your members of the military Force and to Call back the "unvaxxed" [from CoVID-19] members and recall the 10,000 military members dismissed and released by Justin Trudeau.
6. To accept our Flag and Logo as the new symbol for our sovereign Kanatan.
7. To raise this Flag in Ottawa.
8. We require a protection detail on or about the 12<sup>th</sup> -15<sup>th</sup> of June 2022 to provide security for our Peoples travelling via a Bus convoy to Ottawa.
