

Appendix 1: World Renown Medical Experts Say The COVID-19 Vaccine is Dangerous

- 1:32 Cahill: Likelihood of harm to humans is very significant.
- 3:08 Cahill: "Until 2020, zero, mRNA injections were approved in the whole world. Anywhere.
- 3:21 Cahill: “The reason why none of them were approved is when they went into the safety studies and animal studies they cause such severe illness, harm and death they were never regulated or approved.”
- 6:12 Cahill: Why none of these mRNA vaccines were approved is because they prime the immune system ... they turn your own immune system against your own body, quite rapidly. And in the animal studies, made them severely sick or killed them. ... There are a number of names for this vaccine, the names are Antibody Dependent Enhancement (actually, the mRNA enhances the illness or disease), cytokine storm, immune priming, immune super-priming.... it is that the mRNA ramps up the immune system against a viral protein.
- 7:09 Cahill: It turns the people that are injected into a genetically modified organism. You are making a viral [spike] protein... This can integrate into your cells and organs. So, your own immune system starts attacking Depending how you respond ... Your body will start making your immune response T and B cells that will start to try and get

rid of the viral [spike] protein. If these spike proteins are in your heart, spleen, pancreas and lungs, your immune system will attack your own cells.

- 8:47 Cahill: In one care home alone in Ireland in January 2020, of 51 injected 26 died within 5 weeks. Eight people died in one care home in Berlin from one injection and 19 out of 31 died in the same care home from the second injection.

- 3:00 Risch: "Clinicians are telling me that more than half of the new Covid cases that they are seeing to treat are people who have been vaccinated They've estimated that more than 60% of the new cases that they are treating – COVID cases – have been people who have been vaccinated."
- 20:50 Risch: Early outpatient treatment works. "We have [treatment with] hydroxychloroquine, ivermectin, quercetin lots of different outpatient approaches. Most are over the counter. There are generic medications, inexpensive medications. We don't need to be generating \$3,000 per pill treatments [no need to develop treatments,] we have them already. "

- 22:30 Risch: "More than 4,000 variants so far.... All are treatable, [from what I hear from my colleagues] in South Africa and Brazil They are treating them effectively [with hydroxychloroquine, ivermectin, etc.]. The vaccines will work to a greater or lesser degree."

7. [Dr. Robert Malone, M.D., M.Sc.. \(inventor of the COVID-19 vaccine technology\): The vaccinated are at a greater risk of contracting COVID-19 than the unvaccinated.](#)

9. [Dr. Byram Bridle, Ph.D. \(Canadian immunologist\): The vaccine causes cardiovascular and neurological damage.](#)

- Viral immunologist (studies the human immune system)
- Associate Professor Immunology, University of Guelph (Canada)
- Developer of immunization strategies to prevent infectious diseases and treat cancers.

- Before COVID, he was a pro-vaccine advocate

Key Points:

- 1:46 Bridle: "We follow the science carefully... Everything that I am about to state is completely backed up by peer-reviewed, scientific publications. My conclusions:"
 - Covid is harmful because of spike proteins on its surface; it is what infects our bodies.
 - The vaccines work by getting the cells in our bodies to manufacture spike proteins
 - The theory is, our bodies will develop an immune response to the spike proteins.
 - Spike proteins from vaccination circulate in our bodies and accumulate in our vital organs [liver, adrenal, heart, brain, reproductive, etc.].
 - 2:46 "The spike protein [from vaccination] is a pathogenic protein [causing disease], it is a toxin, it can cause damage in our bodies if gets into circulation, now we have clear cut evidence [of this]."
 - 3:01 "The spike proteins combine to the receptors on our platelets and the cells that line our blood vessels. When that happens it can do one of two things, it can cause platelets to clump and that can lead to clotting (that's exactly why is why we have seen clotting disorders ...), it can also lead to bleeding."
 - 3:22 "And of course the heart is involved, it is part of the cardiovascular system, that is why we are seeing heart problems."
 - 3:26 "The protein can also cross the blood-brain barrier and cause neurological damage. That is why also in the fatal cases of blood clots many times it has been in the brain."
- 7:18 Bridle: "What we also know is that proper studies have not been conducted. Remarkably, this [the vaccine's safety] is based on a rat study ... It should have been done on at least two animal models and remarkably, it has not been done on people."
- 7:56 Bridle: "And also what people don't realize and there was no evidence of issues with fertility. These rodents are completely inappropriate models for Covid 19. They don't express the receptors as we do. So of course, you're going to see safety in a model like that. It is an inappropriate animal model. "
- 8:06 Bridle: "Mass vaccination of healthy Canadian children demands that the level of safety is associated with this. The assessed safety profile needs to be exceptionally high. We have had 13 Canadian children under the age of 20 die in 16 months with well over two and a half thousand dying from other causes."
