


Appendix 2: Proof of Death and Injury From the COVID-19 Injection

The following videos and articles report on death and injury arising from the COVID-19 vaccination.

1. [Indiana life insurance CEO says deaths are up 40% \[highest death rates in history\], among people ages 18-64](#)
Jan 1, 2022.
Key Points:
 - The head of Indianapolis-based insurance company OneAmerica said the death rate is up a stunning 40% from pre-pandemic levels among working-age people.
 - “We are seeing, right now, the highest death rates we have seen in the history of this business – not just at OneAmerica,” the company’s CEO Scott Davison said during an online news conference this week. “The data is consistent across every player in that business.”
 - OneAmerica is a \$100 billion insurance company that has had its headquarters in Indianapolis since 1877. The company has approximately 2,400 employees and sells life insurance, including group life insurance to employers nationwide.
2. [400,000 Cases of COVID Vaccine Injuries Found in Data Analyzed by German Health Insurer](#)
Feb 24, 2022. The Defender, Robert F Kennedy Jr.
Key Points:
 - In a letter, Schöffbeck said BKK analyzed doctors’ billing data from 10.9 million insured people and found 217,000 people received medical treatment due to vaccine side effects.
 - “In our opinion, there is a significant underreporting of the side effects of the vaccination,” said Schöffbeck. “According to our calculations, we consider 400,000 visits to the doctor by our insured persons due to vaccination complications to be realistic to date.
3. [US Military Doctors Testify About Vaccine Injuries in the Dept of Defense and One was Ordered to Cover Up the Injuries](#)
April 3, 2022. Dr. Paul Alexander
Key Points:
 - Three military surgeons and a Navy Commander of a warship testified and asserted the high occurrence of adverse events and a cover up.
 - Dr. Theresa Long, a flight surgeon with the United States military, has testified in court that she was ordered by a superior to suppress Covid-19 vaccine injuries following the Biden regime’s mandate. She also holds a master’s degree in public health and is specially trained in the military’s health database. Certain disorders increased by over 1000 percent after the vaccine mandate went into effect. “I have so many soldiers being destroyed by this vaccine.”
 - Colonel/Dr. Tankersley testified that the shots are neither safe nor effective.
 - Dr. Pete Chambers, a Purple Heart recipient was forced to retire due to illness after the vaccine. He pointed out that shots are not effective in preventing infection and estimated that about 75-80% of soldiers getting infected are “double vaxxed” compared to only about 15% of soldiers who are not vaccinated.
 - The Dept. of Defense has not offered a single witness. They only provide legal council. The judge has chastised the DoD lawyers during the hearings, telling them they have “a frail case,” and are “acting as though they are above the law.”
4. [1,249 Athlete Cardiac Arrests, Serious Issues, 847 Dead, After COVID Injection](#)
August 22, 2022. Real Science
Key Points:
 - Gary Dempsey: Was a professional for nearly 20 years. From 1996. Played nearly 500 games ... Never ever was there 1 cardiac arrest.
 - They started happening after the first COVID injection in January 2020.

- The dead athletes (and their circumstances) are all identified at the end of the article with a hyperlink to news report.
- See chart below shows the monthly death rates and collapses starting in January 2021. The death rates are in red and the collapses in blue. Vaccinations started around the end of January 2021.
