## Peoples of the Salmon (Pots) 67 de Jure Governance Meeting

Popois shared what is happening with court (petition hearing)

He was unable to get thru to schedule court date for petition hearing and asked if anyone is available to call them and schedule date for 2nd or 3rd week of June . Number to call - 1-604-660-2853 and case #S2110969. If successful in scheduling court date - advise Popois

### **1. Investigations**

Popois gave update on investigation, stating chiefs are afraid to give up their meal ticket they get from defacto government. They are also relying on PotS to do all the work for them in gaining our lands back.

Issue: Non-original peoples as Chief Justice ? - How will future courts operate? Original peoples, Quazi systems or lower land courts (civil)

Suggestion: we make peoples part of justice in our lower level justice system (civil matters), and have original peoples handle the higher level justice (criminal matters). N

### **2. Lands**

Popois "Rights & Title" Team is 12-13 tribunal + members strong

UNITY = Joint Tenancy according to Blacks Law Corporatocracy

**Our Rights stem from the Land (Terra) and its valuable of resources** (including sovran value: connection to Source and all things, opening up our relationship to all things and that power) **and what we do with that value.**

Popois reminded us of the Chilcotin court case and how they got their lands back, this means that all the lands have been given back to all peoples of Kanat'an – all lands are included in this.

PotS work is to acquire proof of Land **Titles**, put Titles in our name, remove from Crown/BC etc., and give the Peoples **Rights** back on the Lands. Determine resources, proof of assets (engineering reports), deposit value in bank. Walk with our property together.

Confirmed that we now have 2 properties in PotS tribe and have sovrans on the land

Between PotS Alliances and AIN - Kanat'an is the only real country because peoples are still here

Canada is using Indian Act to usurp bonds to comply, bribing chiefs and hereditary's and by threatening their "meal ticket". Band Council/Handlers Vs. Hereditary Peoples. \$860,000 covid funds bribed peoples to keep it going. Goes to government of Canada, 30 % indian affairs, 10% peoples.

### 3. **Food Sovereignty**

We must create networking, security, abundance, distribution, currencies.

Project: Food Community Garden: Lower Mainland Vancouver: Team Leader: Brian asks for peoples step forward and help him acquire a plot to plant, maintain and harvest food. Potential: Build small Booth to market/sell harvest.

Project: Food Plantation: North of Edmonton: Team Leader: Muskwa: Tower gardens financing may be in place, have 40 towers but need 100, requires lighting, power, etc. **EVENT:** After April 14, 15 and 16 ceremony in Edmonton, they are anticipating weekly turnover of harvest, help will be required to pick harvest.

Project: Rivers will have lots of salmon and thus put boats to catch our own and process fish ourselves, 2 rivers; Fraser and Skeena (and Anast?) Team Leader? Popois: We can then start to do business selling our catch. There was some concern about salmon stock levels due to flooding – but feeling is they will be plentiful. It was estimated that we could process 250-500 salmon per weekend; clean and put in freezer, table accordingly and kept for dinners. Fisherman – Vancouver island and Powell River.

Project: 3 large green houses in Powell River: team Leader: Jaime Rosa?

Project: 6 large green houses in Williams Lake

Online Tool Development: We are creating a directory with participants (active members in the community) plus all project information (projects: business plans) from A-Z of what is needed for each vertical of business. Example was given for a "greenhouse" business. It was suggested to have a community shore with boats, supplies, catch, canning, smoking and supply chains to our peoples

### 4. **Bank Terms - where we are going**

Gave an update on existing properties having value, stating that engineering report is needed for proof of assets.

There was some discussion on using Spades as a viable platform but Popois does not believe it is a good fit.

They are looking at different systems such as; blockchain, smart contracts, wallet systems. Having banks around the world.

Black Feet hired a 21 yr old from Australia who is an IT expert and will help us build and support systems.

Announcement: Popois was made CEO of Nisitapee Salmon Eagle Bank.

What we have, and what we need doesn't exist on Turtle Island yet but we are working towards this.

6. **Website, purpose of the site, member and shop services are available**

It's there to provide information, products, and services to everyone interested in becoming a part of PotS  
Members must be capable of taking responsibility for themselves as sovran souls. We are all learning as we reclaim our sovereignty.

It was stated that Monique (central ops) is not online to assist with personal stuff, and website is not intended to be a tool for legal advice. 7. **Directory coming**

Popois explained how it works, add your projects, add you as participants. start your own project using 25yr plan/SSG as your guide; working on directory

Directory projects: donations can be created in the shop to support per project to cover costs, e.g. expenses incurred by headsman and other staff.

It was suggested that we put together a campaign to educate people on what we have to offer, in hopes to sell memberships. Releasing a newsletter soon. Want a clear campaign.

8. **Member Services and getting our Instruments online**

Start a sovran plan and fill out your Profile to populate instruments, e.g. Kanat'an Travelling Plates, or Sovran ID Card (could be made into stickers to place on windows of vehicle, 4 corners, to claim jurisdiction). Once you have all required documents, sovrans say police will leave you alone.

NEVER hand your documents, only show them through the car window.

Where do we need to give notices to different offices to state we operate as sovrans in Canada

Monique walked us thru getting ID card then showed how other instruments are populated with the same info we entered in our member Profile online, then showed us a completed instrument example.

All instrument and cards can be purchased in the shop online.

Newsletter being released to 35k people soon; Campaign to get started soon

9. **Council of 13 - Next weekend in Edmonton - April 14, 15 and 16**

Purpose; 13 council members coming together to form New Alliance of Kanat'an

A request was made for donations to assist headsman in getting to Edmonton (flight, etc)

We represent 66% of those who want change in government and on our lands and Council of 13 will evaluate what directions to go with land and rights

Popois further explained all aspects; fisheries, Child/Family services, court systems, social media regulations, land rights, mandates, etc.
